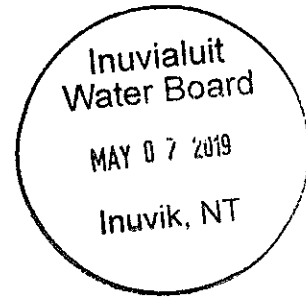

**TOWN OF INUVIK
BY-LAW #2504/H&S/11**

A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE NORTHWEST TERRITORIES TO ESTABLISH DUMPING FEES AT THE TOWN'S LAND FILL SITE

WHEREAS, pursuant to Section 72 of the Cities, Towns and Villages Act, S.N.W.T. 2003, c.22, and subsequent amendments thereto, which state:

72. For greater certainty, a bylaw may

- (e) establish fees or other charges for products, programs, services, public utilities, infrastructure and facilities provided or done by the municipal corporation or for the use of property under the ownership, direction, management or control of the municipal corporation;

AND WHEREAS the Council of the Municipal Corporation of the Town of Inuvik deems is desirable and necessary to levy dumping fees for all commercial, industrial and institutional users at the Town's land fill site;

NOW THEREFORE BE IT RESOLVED that the Council of the Municipal Corporation of the Town of Inuvik, in Council duly assembled, enacts as follows:

- 4. That the following dumping fees will be charged at the Town's land fill site, and will be applicable to all commercial, institutional and industrial users ~~whether local or out of town:~~

Load Type	Category and Fees	
	Garbage	Out of Town Garbage
Extra Large Loads (End dump and any tractor trailer combinations)	\$325.00 per load	\$1,000.00 per load
Large Loads (Dump truck and any straight truck combinations)	\$125.00 per load	\$800.00 per load
Medium Loads (1 ton units and pick-up and trailer combinations)	\$65.00 per load	\$600.00 per load
Small Loads (1/2 ton up to 1 ton loads)	\$35.00 per load	\$400.00 per load

Note: All private residential users of the landfill site will be exempted from garbage dumping fees only. At no time shall the community accept any hazardous or contaminated industrial waste from out of town.

- 2. By-law #1944/H&S/01 is hereby repealed.
- 3. This by-law will come into effect upon the day of its final passage.
