Attached is an amended cover page for Water Licence N7L3-0714. This amendment has been granted to the Hamlet of Tuktoyaktuk by the Northwest Territories Water Board (the Water Board) in accordance with the *Northwest Territories Waters Act*. A copy of this Licence has been filed in the Public Registry at the Water Board offices in Inuvik and Yellowknife.

Water Licence N7L3-0714 has been amended to reflect an extension deemed necessary by the Water Board to ensure a proper review of the submitted application for renewal. The amended expiry date for the Licence is now April 30th, 2009. No conditions of the licence have been changed and the Hamlet is to continue to abide by the current licence conditions until a licence renewal has been issued.

This letter along with the amended Licence cover letter are part of the Public Registry and are intended to keep all interested parties informed of the manner in which the Licence requirements are being met.

In future, please ensure that the complete application for licence renewal is submitted at least 3 months in advance of the licence expiration date.
