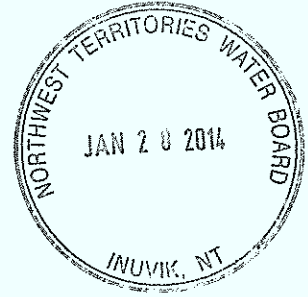

Reporting Year 2013



1. Water usage: as per attached spreadsheet, the Hamlet was filing as per the fiscal year so there is an overlap in the years
2. Solid waste and sewage deposited: same amount as water consumption as what is taken in the same amount comes out.
3. Hazardous waste storage and transportation: no monthly records have been kept
The Hamlet did not transport any hazardous material out of the community.
4. A new truck discharge chute was built and installed and is observed as being effective for proper discharge to the sewage lagoon.
5. Clean up is ongoing at the site and as a result for request from NWTHC disposing of old units the Hamlet developed and passed a tipping fee by-law.
6. Spill reports were received from ENR and filed.
7. Ongoing and education to Council and the public has been a priority. Hamlet staff has attended workshops and training in how to develop spill plans etc. and are trying to meet the deadlines for these plans.
8. No studies were requested.
9. The Environmental Health Officer gets copies of all lab results for samples that are sent in.
10. During the Spring of 2013 the Hamlet experienced high water conditions and declared a state of Emergency due to flooding. This created problems for access to the sewage lagoon and so in consultation and approval from Indian and Northern Affairs the sewage was disposed of at the North end of the Aklavik Airstrip. This lasted for 10 days and a spill report was provided to INAC.
11. The Hamlet of Aklavik continues to do ongoing pushing of the dump to avoid any issues with bears and other animals.
