**Re: N7L3-1531 Hamlet of Sachs Harbour Municipal Water Licence – 2015 Annual Report**


The Inuvialuit Water Board (IWB) acknowledges receipt of the Hamlet of Sachs Harbour 2015 Annual Report submitted on May 3, 2016. The IWB has completed a review of the annual report and as a result of the review, information gaps have been identified. As per the following terms of the licence, please provide the following:

1. N7L3-1531 Part B, Item 1b) the monthly and annual quantities of each and all Wastes discharged, including Sewage discharged to the Sewage Disposal Facilities;
2. N7L3-1531 Part B, Item 1c) a summary of the monthly and annual quantities of hazardous Waste stored on site and transported off site;
3. N7L3-1531 Part B, Item 1) any problems, modifications or repairs done to the Water Supply and Waste Disposal Facilities, including all associated structures;
4. N7L3-1531 Part B, Item 1f) tabular summaries of all data generated under the "Surveillance Network Program";
5. N7L3-1531 Part B, Item 1g) a list of spills and unauthorized discharges;
6. N7L3-1531 Part B, Item 1h) an outline of any Spill training and/or other operator training carried out;
7. N7L3-1531 Part B, Item 1i) a summary of any closure and reclamation work completed during the year and an outline of any work anticipated for the next year;
8. N7L3-1531 Part B, Item 1j) a summary of any studies requested by the Board that relate to Waste disposal, water use or reclamation and a brief description of any future studies planned;

9. N7L3-1531 Part B, Item 1k) updates and/or revisions to the approved Spill Contingency Plan, Municipal Solid Waste Operations and Maintenance Plan, and Sewage Treatment Plan; and
10. N7L3-1531 Part B, item 1l) any other details on Waste disposal or water use requested by the Board by November 1st of the year being reported.
